Deglobalization

Challenges for Regulation, Trade and Monetary Policies

CIDEEFF invites the academic community to submit scientific articles for the Conference *Deglobalization: Challenges for Regulation, Tariffs, and Monetary Policies*, to be held in a hybrid format on February 27.

Complete draft articles must be submitted by **January 23, 2026, at 23:59 (Lisbon time, GMT)**.

Papers should address the topic of *Deglobalization: Challenges for Regulation, Tariffs, and Monetary Policies* along the following lines of inquiry:

Backlash against Regulation: There is a global trend to cut economic rules. Despite past efforts to reduce red tape, regulation has become increasingly cumbersome in recent years. Politicians desperate for growth seek to eliminate unnecessary and excessive bureaucratic hurdles. If handled properly, this could bring greater freedom, faster growth, lower prices, and new technologies. Yet, it carries both risks and potential benefits.

Tariffs as the “Big Beautiful” Revenue Source: Could the introduction of tariffs replace current budget funding through corporate and personal income taxes? Would such a policy comply with the ability-to-pay principle, the international tax system, tax neutrality, and fairness? How should unilateral approaches toward digital giants be characterized? Are Digital Services Taxes (DSTs) tariffs? Are DSTs discriminatory? Is VAT on imports equivalent to a tariff?

The Crisis of Multilateralism: The promise of a globally interconnected world, nurtured by decades of growing economic cooperation, is now under severe strain due to protectionist policies, unilateral sanctions, and the alarming use of military and economic coercion. Institutions such as the United Nations, the International Monetary Fund, and the World Trade Organization—as well as informal forums like the G7, G20, and BRICS—now face profound challenges. This erosion of multilateralism leaves the world

vulnerable to escalating conflicts and unresolved global issues, including climate change, pandemics, ocean pollution, nuclear proliferation, and economic nationalism.

The Assault on the Global Dollar: Monetary policy and contagion effects of U.S. export tariffs; central bank independence and political interference; the role of the U.S. dollar in the international system; international cooperation among central banks.

Articles may be submitted in English, individually or in co-authorship (maximum of three authors), by contributors from any academic background.

Papers should be submitted by email to cideeff@fd.ulisboa.pt and must include the following information:

- Author(s) name, title, and institutional affiliation.
- Paper title and an abstract of no more than 200 words.
- The complete draft article, up to 30 pages, formatted according to the CIDEEFF House Style (see below).

Selected authors will be notified of acceptance by **January 30, 2026**. Accepted articles will be presented at the conference on **February 27** and published in the *CIDEEFF Working Papers* series and in the book resulting from the conference.

Authors will have a maximum of **10 minutes** to present their papers.

Font: Times New Roman, size 12

Paragraph spacing: 1.5 line spacing

Dates: Use European style (day–month–year)

Numbers: Use numerals for units of time (or other measures) in non-technical text, numbers greater than ninety-nine, dates and times, statistics (including decimals, percentages (15%), ratios, ages, monetary figures), numbers in a series (5, 10, and 250 years), and number ranges (2–4; 204–209).

Abbreviations: When introducing an abbreviated form, provide the full name followed by the abbreviation in parentheses the first time it appears.

Citation Style:

- *Books and non-periodic works:* Author, *Title*, Editor [if any], Translator [if any], Edition [if any], Publisher, Date, Pinpoint page.
- *Articles in periodicals:* Author, “Title,” Volume number *Periodical Abbreviation* (Date), initial page, pinpoint page.
- *Internet sources:* Author/Owner, *Title*, URL (Access or update information), exact date of access.
- *Cases:* *Case Name*, Reporter volume, Reporter abbreviation, initial page, pinpoint page (Court abbreviation Date), subsequent history [if any].
- *International legal material:* *Title*, pinpoint reference, exact date, Source.

Short references: The first citation must be full; subsequent references should use: Author’s Last Name (or, if unavailable, Title), *supra* note X, at pinpoint reference.
